

Safe Use of Hand Held Application in/near water

This course prepares the trainee to take the City and Guilds practical assessment, which combined with the Safe Use of Pesticides unit qualifies the operator in the legislative qualification. By doing the application in/near water only (and not hand held application as well) it does mean that the candidate will only be able to spray around the buffer zone of a water course and not on any open land.

One Day Training with assessment to follow on a separate day.
09.00 – 16.30 approx.

Half Day Training with assessment to follow on in the afternoon; if time permits, when done alongside Hand Held Application.
09.00 – 12.30 approx.

When this unit is completed alongside other pesticide units we will endeavour to organise all assessments for the same day.

Safe Use of Hand Held Application in/near water Venue Requirements (if course is at your site)

Room/ Area Required

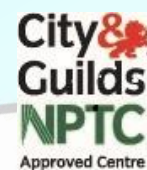
- For theory sessions: A dry, clean and warm room with power supply, tables and chairs for all trainees.
- Flipchart or whiteboard and marker pens.
- Area of grass or concrete alongside a 100m length of ditch suitable for spraying with water
- Washroom and toilet facilities.
- First Aid Equipment.
- Fire Extinguisher.

Equipment Required

- 1 knapsack per trainee, in good working order.
- Operator manual.
- Measuring jugs.
- Measuring tapes.
- Markers for areas.
- Water supply.
- PPE for all trainees to include protective coveralls e.g. DuPont Tyvek Type 4/5 & 5/6, wellington boots, visors & nitrile gloves

Other Requirements

- Upon arrival on site the instructor may postpone the training or assessment if the equipment or site are unsuitable. Payment will still be due and there will be an extra cost for the rescheduled day.
- All trainees must be fit enough for the training or assessment.
- We require one passport sized photograph of the candidate to be supplied electronically before the assessment otherwise extra costs will be incurred to provide an ID card later.
