Safe Use of Broadcast or Variable Geometry Boom Sprayer (mounted or trailed) with or without air assistance Venue Requirements (if course is at your site)

Room/ Area Required

- For theory sessions: A dry, clean and warm room with power supply, tables and chairs for all trainees.
- Flipchart or whiteboard and marker pens.
- A 50 metre length of hedging/vines or similar to spray with water.
- Washroom and toilet facilities.
- First Aid Equipment.
- Fire Extinguisher.

Equipment Required

- A tractor and variable geometry or broadcast sprayer in good working order.
- Operator manual.
- Measuring jugs.
- Measuring tapes.
- Markers for areas.
- Water supply.
- PPE for all trainees to include protective coveralls e.g. DuPont Tyvek Type 4/5 5/6, wellington boots, visors, nitrile gloves.

Other Requirements

- Upon arrival on site the instructor may postpone the training or assessment if the equipment or site are unsuitable. Payment will still be due and there will be an extra cost for the rescheduled day.
- All trainees must be fit enough for the training or assessment.
- We require one passport sized photograph of the candidate to be supplied electronically before the assessment or taken at the time of the assessment otherwise extra costs will be incurred to provide an ID card later.
- All trainees must have completed Safe Use of Pesticides.
